Key CMS LTCF Emergency Preparedness Updates

- ► Emergency planning is still required as outlined in the CMS Emergency Planning Checklist memo to state directors dated February 28, 2014. Emerging infectious diseases, personal protective equipment (PPE), etc. language added.
- ► Training of staff, volunteers, and contractors on EP and Communications plans at least once a year and updated as facility risk assessments are updated.
- ▶ **If** a Hospital, CAH, or LTC facility determines that the use of a portable and mobile generator would be the best way to accommodate......**IF** there is a permanent generator......




